#### 2962 PROPERTY

2962.1 Moss – it was **NOTED** that the warm wet weather this year had resulted in an explosion of moss all across the parish facilities; Swallowfield Parish Hall car park, MUGA and children's play area at Swallowfield, Riseley and Farley Hill. The council's grounds maintenance contractor had advised that each area would need to be treated at least twice.

It was **PROPOSED** and seconded that the council's grounds maintenance contractor be engaged to apply twice, an appropriate treatment at a cost of £1,496 plus VAT and a third treatment, if required, at a cost of £748 plus VAT. All in favour. <sup>6</sup>
