- 2997.1 Swallowfield Parish Hall Upgrade
- 2997.1.1 Automatic door it was **NOTED** that under delegate powers (Resolution 2806.1.5.2) the builder had been instructed to order and fit an automated door opener/closer for the door leading from the atrium to the Main Hall at a cost of £3,399 plus VAT.
- 2997.2 Work Surface on hatch it was **NOTED** that there had been a concern raised regarding the edge of the work surface which protrudes into the hall. It was **AGREED** that the most appropriate solution would be to add an additional piece of work surface. The architect and building contractor would agree an appropriate method of fixing. It had not been possible to source an off-cut of the surfacing so the cost would be approximately £700 plus VAT.

It was **AGREED** that the final solution would be agreed under delegated powers (Resolution 2806.1.5.2)

2997.3 Riseley Sports Pavilion - it was **NOTED** that the drainpipe/guttering which caused the leak in the roof of the Sports Pavilion would be repaired at a cost of £180 plus VAT.

The Parish Council objected to the previous application, 232783, for 6 additional units for the following reasons: For very many years the site was only home to one caravan, subsequent applications which have been deemed lawful brought the total to twelve, this latest application, like 201111 and 232786, increase the number to fifteen and the parish council believes that this will make a material difference. The Parish Council would also like to point out that this part of Part Lane has been the subject of severe flooding including part of this site. nearest Part Lane. This

				 flooding has affected properties along the road, so any additional hardstanding will put properties at further risk. The council notes WBC's reasons for refusal of application 201111 and would expect WBC to take the same stance with this application. It was PROPOSED and seconded that the council reiterates its objection. All in favour.
2993.1.3	250373	Certificate of Lawfulness	Robin Lodge Nursery Part Lane Swallowfield RG7 1TB	 Application for a certificate of lawfulness for the proposed erection of boundary treatment. Cllr. Anderson noted that the proposed fencing would be even more incongruous and unnatural in the landscape as the bund proposed in the previous application (231233) which was refused by Wokingham and then dismissed on appeal. The appeal inspector also noted that whilst views into the site would be very limited, the bunds would have a negative effect on the character and appearance of the area which would conflict with LP Policies CP1, CP3 and CP11, as well as Policies CC03 and TB21 of the Managing Development Delivery Local Plan, 2014 (the MDD). The relevant aspects of these policies seek to ensure that development maintains the quality of the environment while preserving character and appearance, including green infrastructure networks such as areas of countryside. It was PROPOSED and seconded that the council reiterates its concerns. All in favour.
